Section 3 – Scope of Services

The selected individual or organisation will be responsible for driving sponsorship and partnership development activities. These may include:

- Developing and implementing a sponsorship engagement strategy;
- Identifying, targeting, and approaching potential sponsors and partners;
- Preparing and presenting sponsorship proposals and agreements
- Managing leads, follow-ups, and relationship development;
- Supporting fulfilment of sponsorship deliverables and recognition; and
- Providing regular progress updates and reports to the Board.

Section 4 – Skills and Experience

EOI respondents should demonstrate:

- Proven experience in sponsorship sales, business development, or fundraising;
- Strong understanding of corporate partnerships and marketing communications;
- Ability to develop and maintain relationships with industry stakeholders;
- Excellent written and verbal communication skills; and
- Knowledge of water, environment, or infrastructure sectors (desirable).

Section 6 – Remuneration Preference

Stormwater Australia's preference is for this engagement to be performance-based, where the selected consultant or organisation is remunerated through a percentage of sponsorship funds

EOIs must include the following supporting documents (as applicable):

- 1. Company Profile or Professional CV outlining relevant experience over the past 5 years.
- 2. Proposal or Methodology describing your approach to sponsorship generation and partnership development.
- 3. Fee Structure including proposed commission percentage and any alternate models if applicable.
- 4. Referees (minimum of 2) including names, contact details, and project or client references.
- 5. Conflict of Interest Declaration disclosing any current or potential conflicts of interest.
- 6. Certificates of Currency (optional) if available, for insurance policies relevant to professional services.
- 7. Any additional supporting material such as case studies, sample proposals, or client testimonials.
